# **Basic Purpose of Position:**

To ensure a safe, orderly and expeditious flow of air traffic based on rules, regulations and procedures.

#### **Analysis of Position:**

Essential Duties and Responsibilities

- 1. Provide Aerodrome Control Service and as such is responsible for the efficient control of aerodrome traffic and ground movements.
- 2. Provide Flight Information Service.
- 3. Provide Alerting Service.
- 4. Coordinate traffic as necessary in accordance with ICAO Document 4444, Belize Civil Aviation Regulations Air Traffic Services and other related documents.
- 5. Assist the ATCO Grade III in certain minor tasks as required.
- 6. Attend training when required.
- 7. Execute other duties as may be assigned from time to time.

#### **Reporting Responsibility:**

The Air Traffic Control Assistant reports to the Chief Air Traffic Officer.

# **Qualifications Required:**

Associates Degree plus 3 CXC passes in Mathematics, English Language and Spanish - General Proficiency I/II (III since June 1998). Prior experience in the aviation industry is desirable, but not necessary as training will be provided. Fluency in speaking Spanish is an asset.

#### **Skills**:

Ability to speak (enunciate), write and understand English, critical thinking skills, ability to make decisions quickly, human relations, interpersonal skills, good memory, listening skills and be able to manage stress.

Due to the nature of the job, shortlisted applicants will be required to undergo an aptitude test and a psychological evaluation.
